

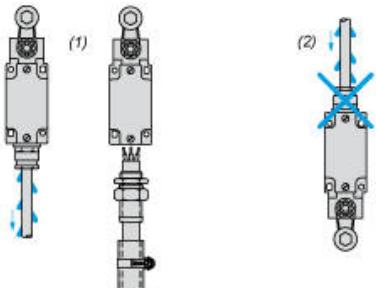

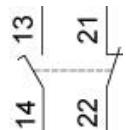

2-pole N/C + N/O Break before Make, Slow Break

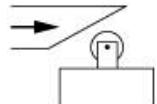


#### Switch Actuation by 30° Cam
