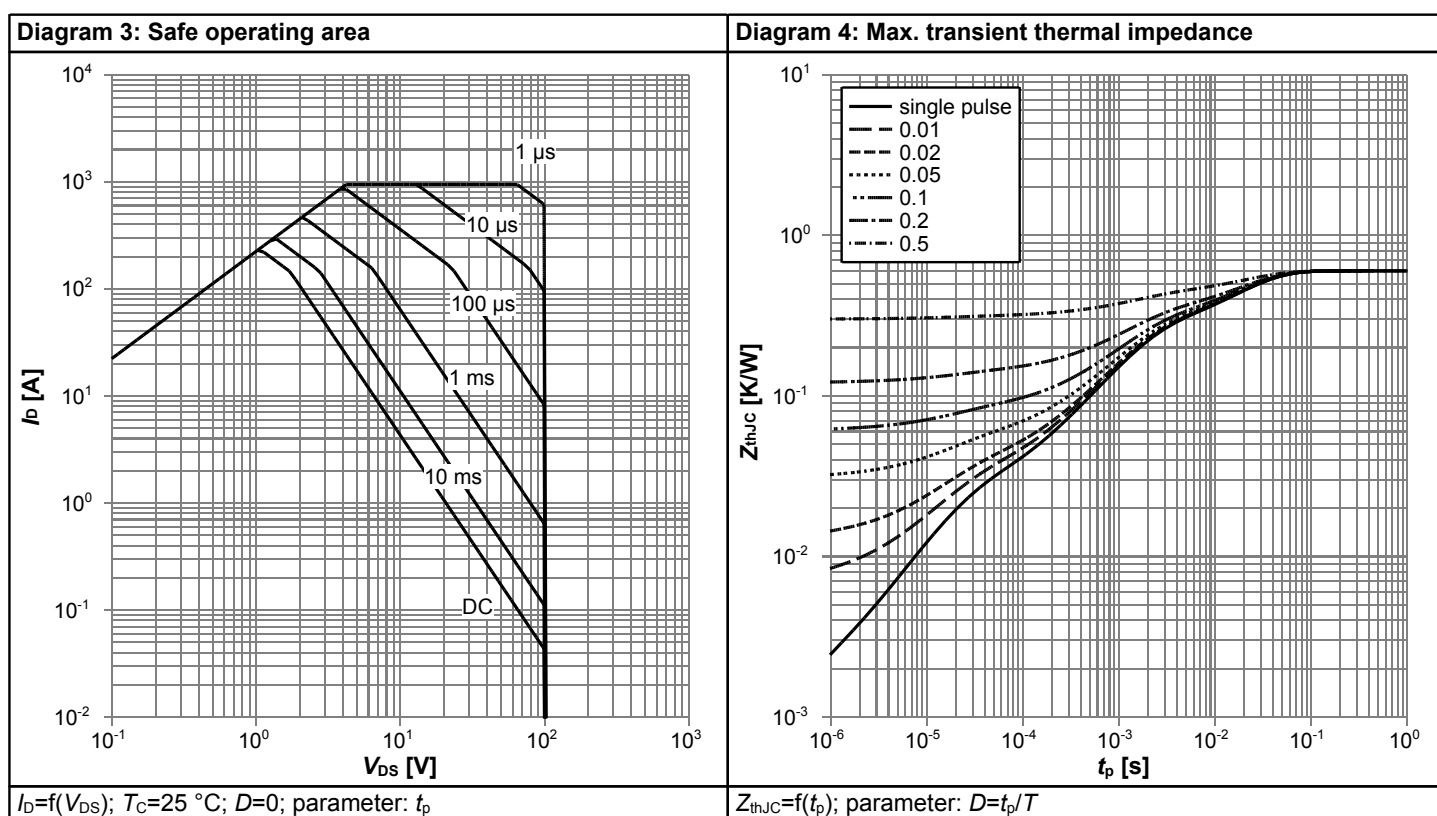
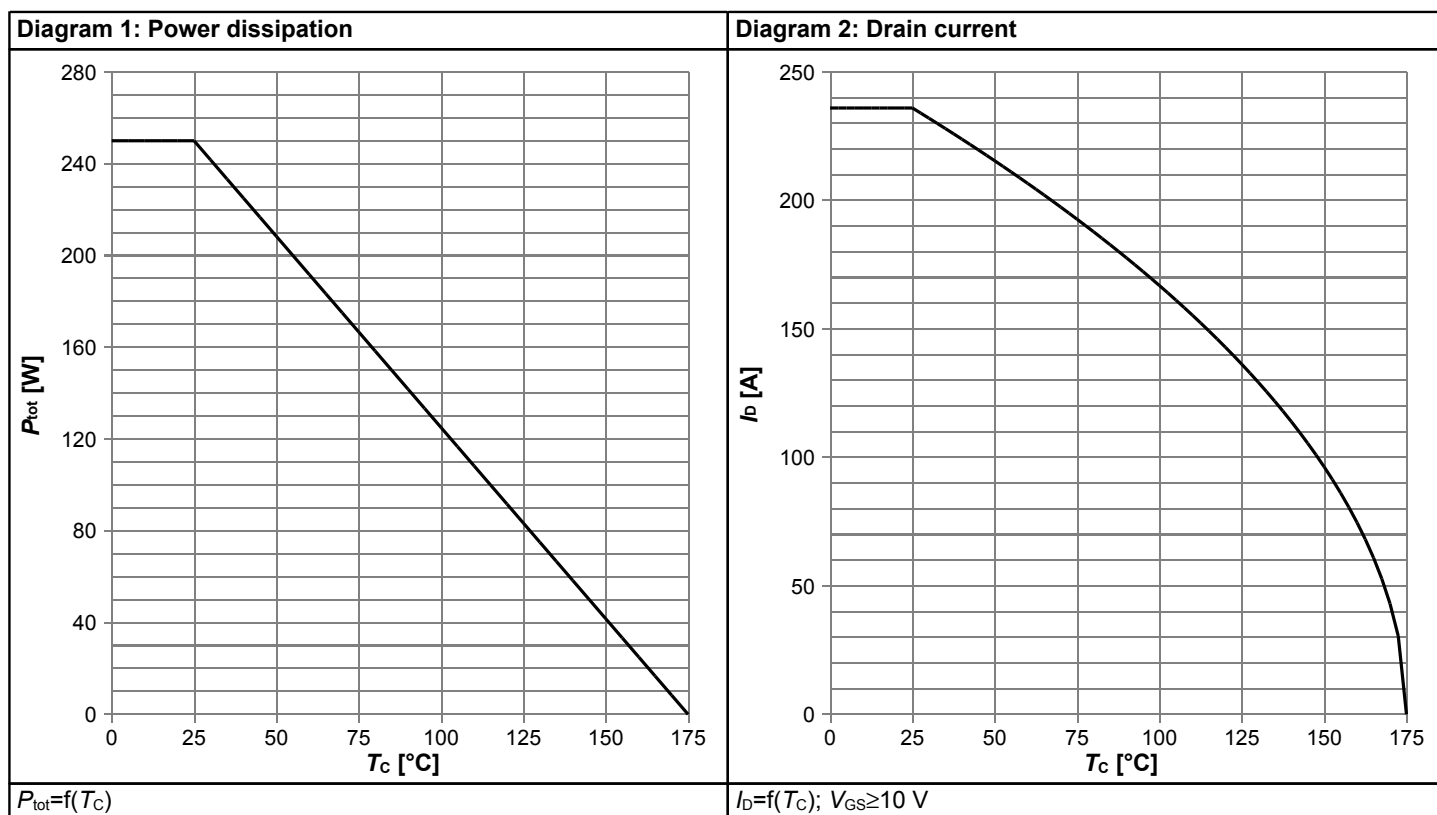

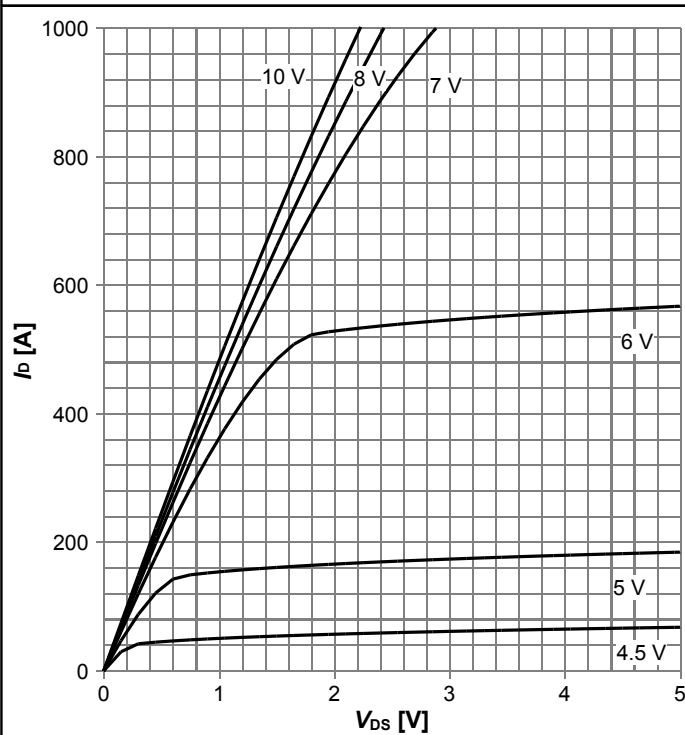

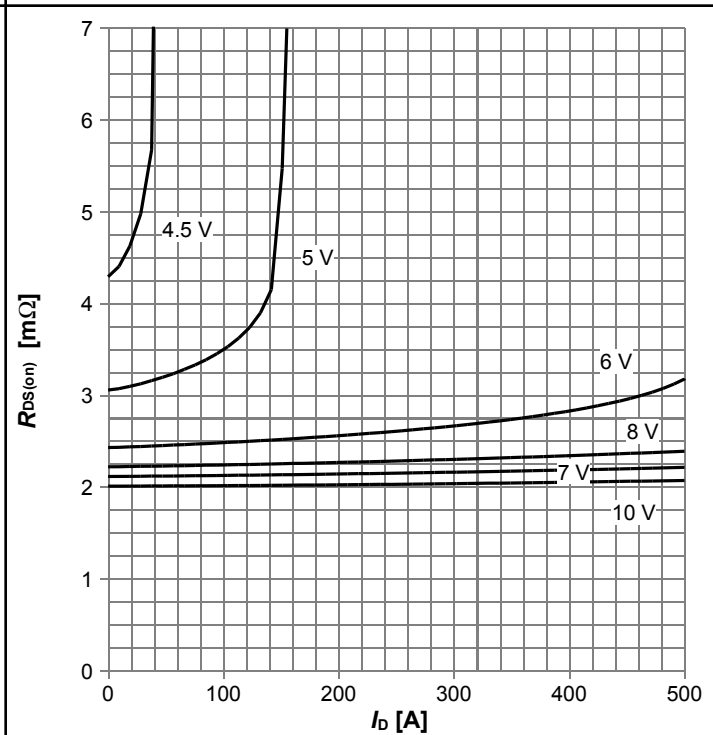

Diagram 5: Typ. output characteristics



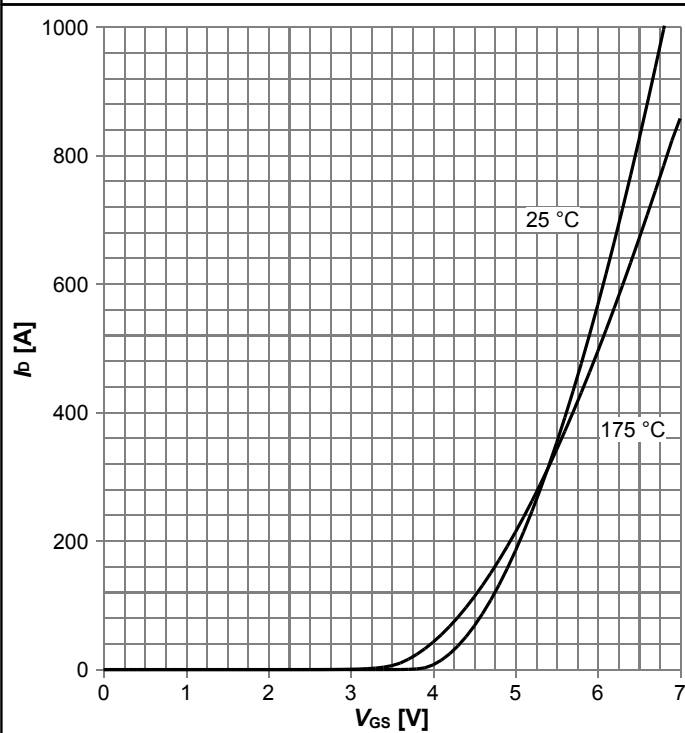
$I_D = f(V_{DS})$, $T_j = 25^\circ\text{C}$; parameter: V_{GS}

Diagram 6: Typ. drain-source on resistance



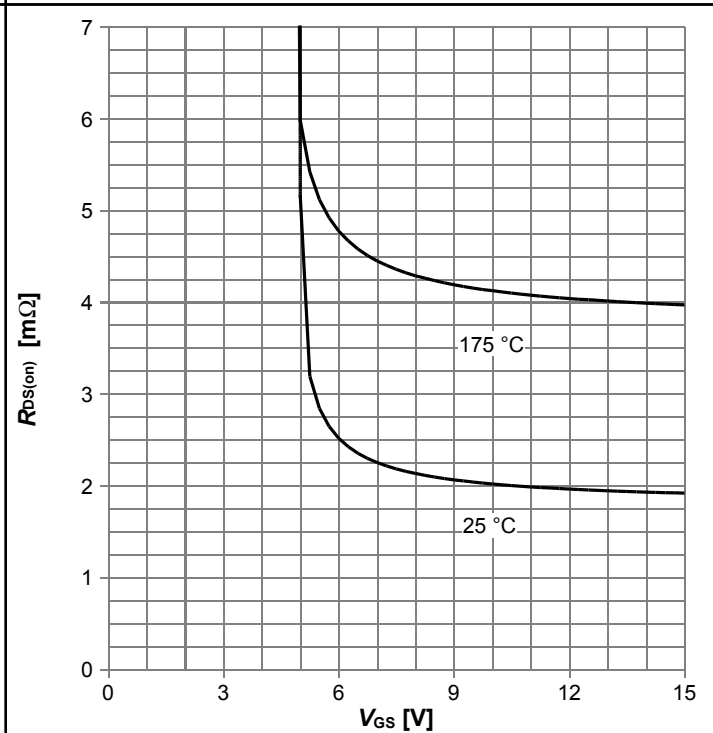
$R_{DS(on)} = f(I_D)$, $T_j = 25^\circ\text{C}$; parameter: V_{GS}

Diagram 7: Typ. transfer characteristics



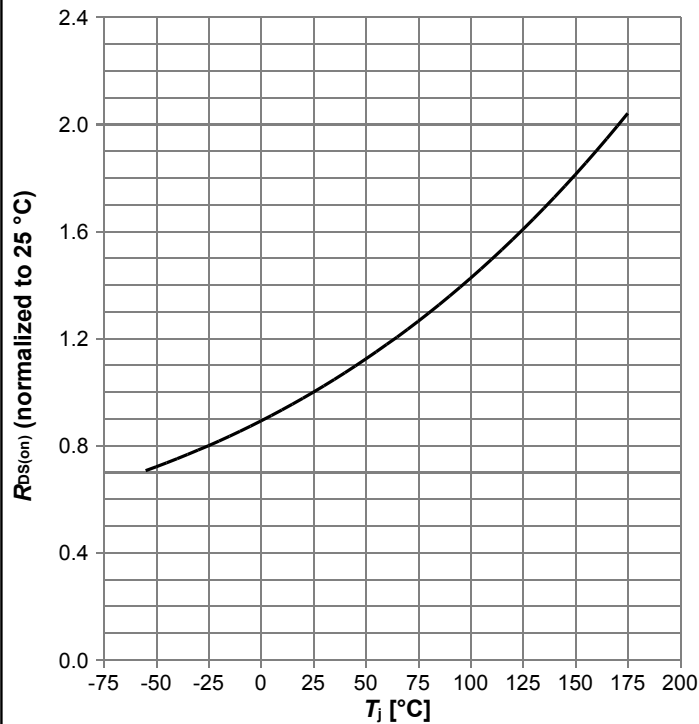

Diagram 8: Typ. drain-source on resistance



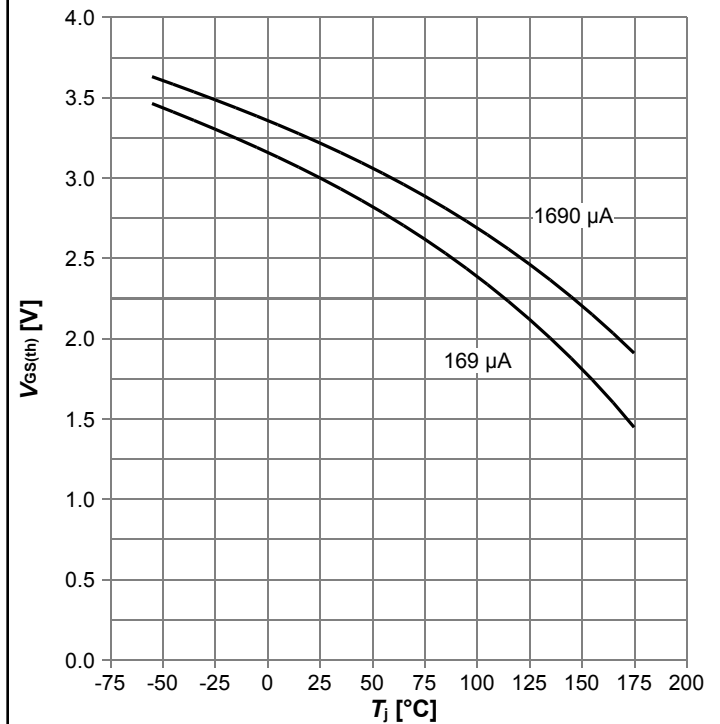
$R_{DS(on)} = f(V_{GS})$, $I_D = 150\text{ A}$; parameter: T_j

Diagram 9: Normalized drain-source on resistance



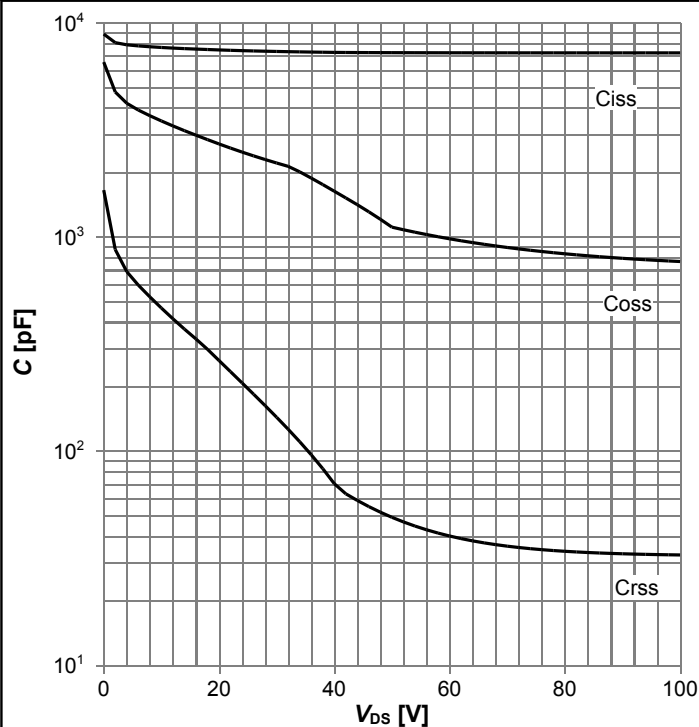

Diagram 10: Typ. gate threshold voltage



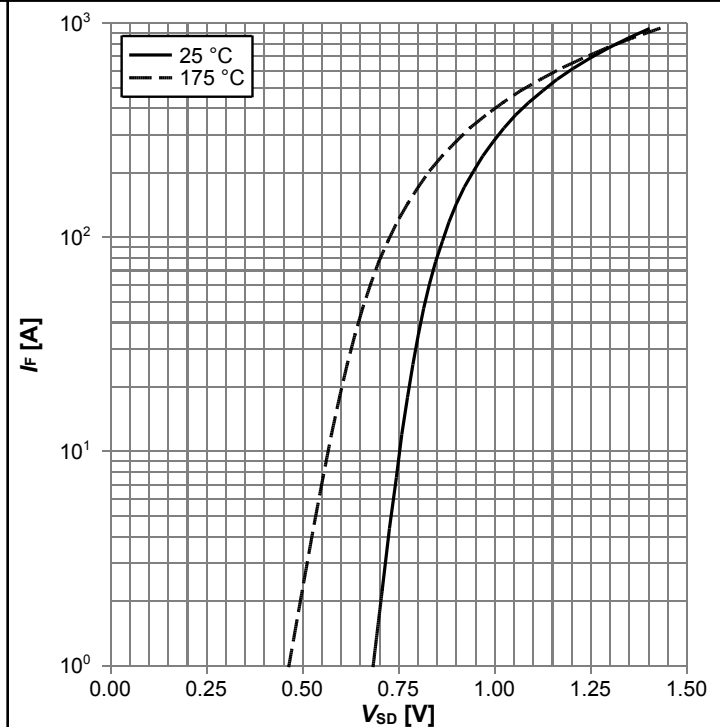
$V_{GS(th)}=f(T_j)$, $V_{GS}=V_{DS}$; parameter: I_D

Diagram 11: Typ. capacitances



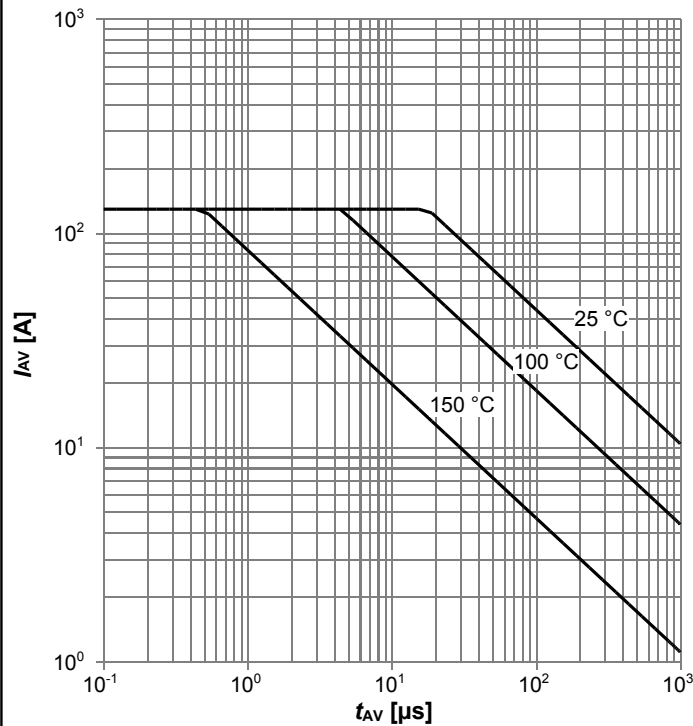

Diagram 12: Typ. forward characteristics of reverse diode



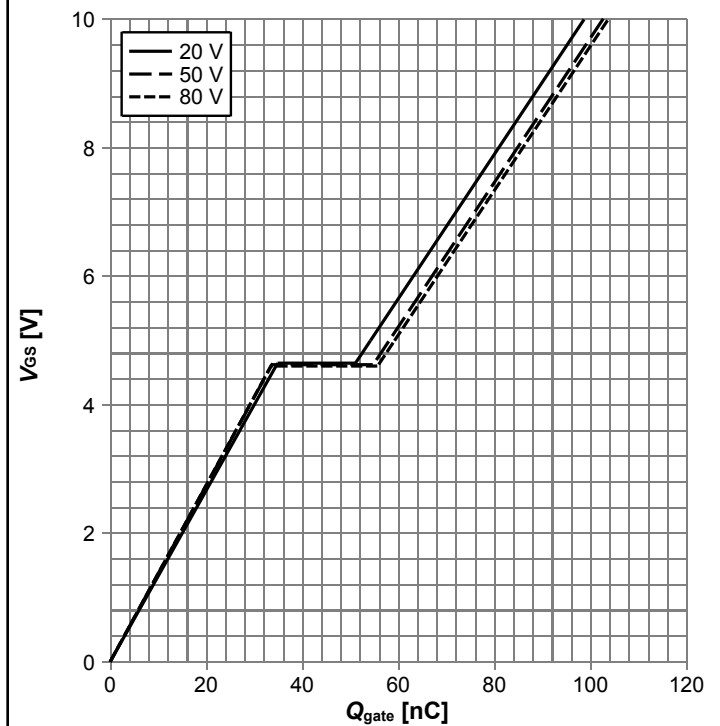

Diagram 13: Avalanche characteristics



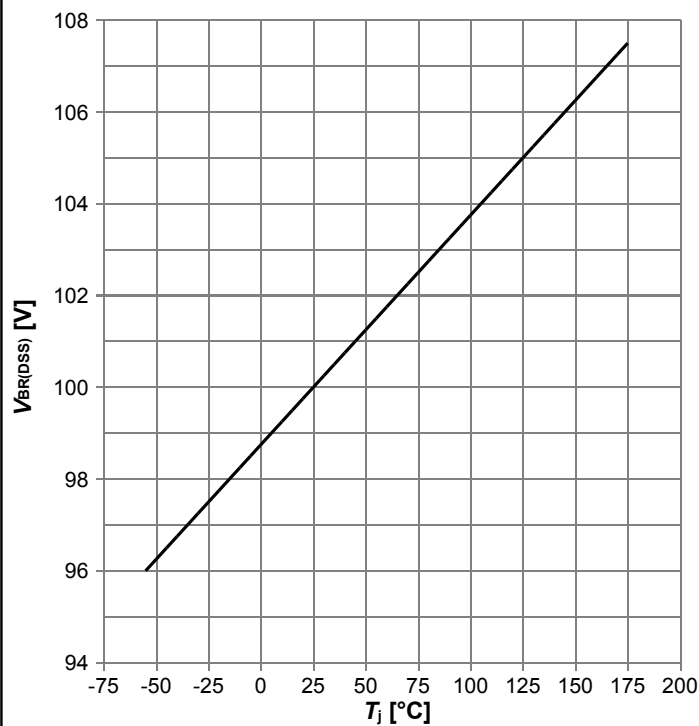

Diagram 14: Typ. gate charge



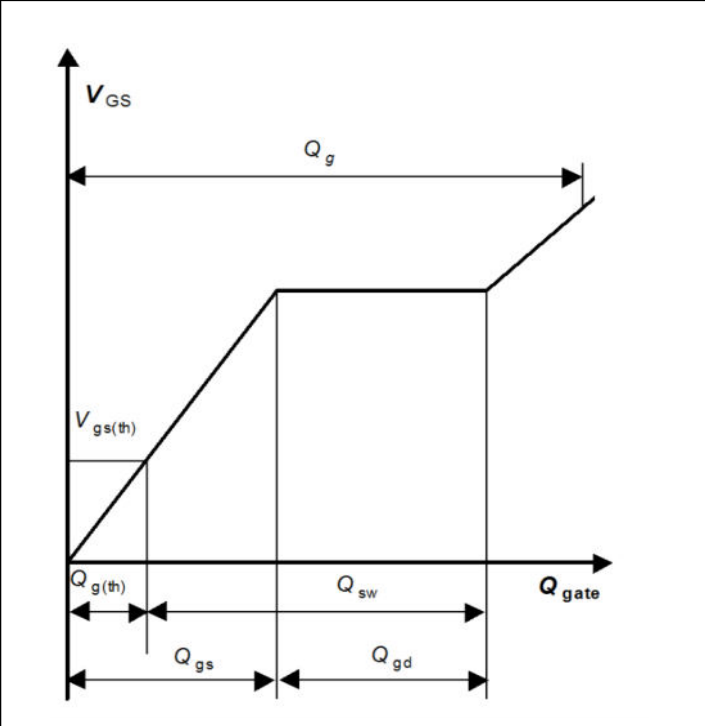
$V_{GS}=f(Q_{gate})$, $I_D=100$ A pulsed, $T_j=25$ °C; parameter: V_{DD}

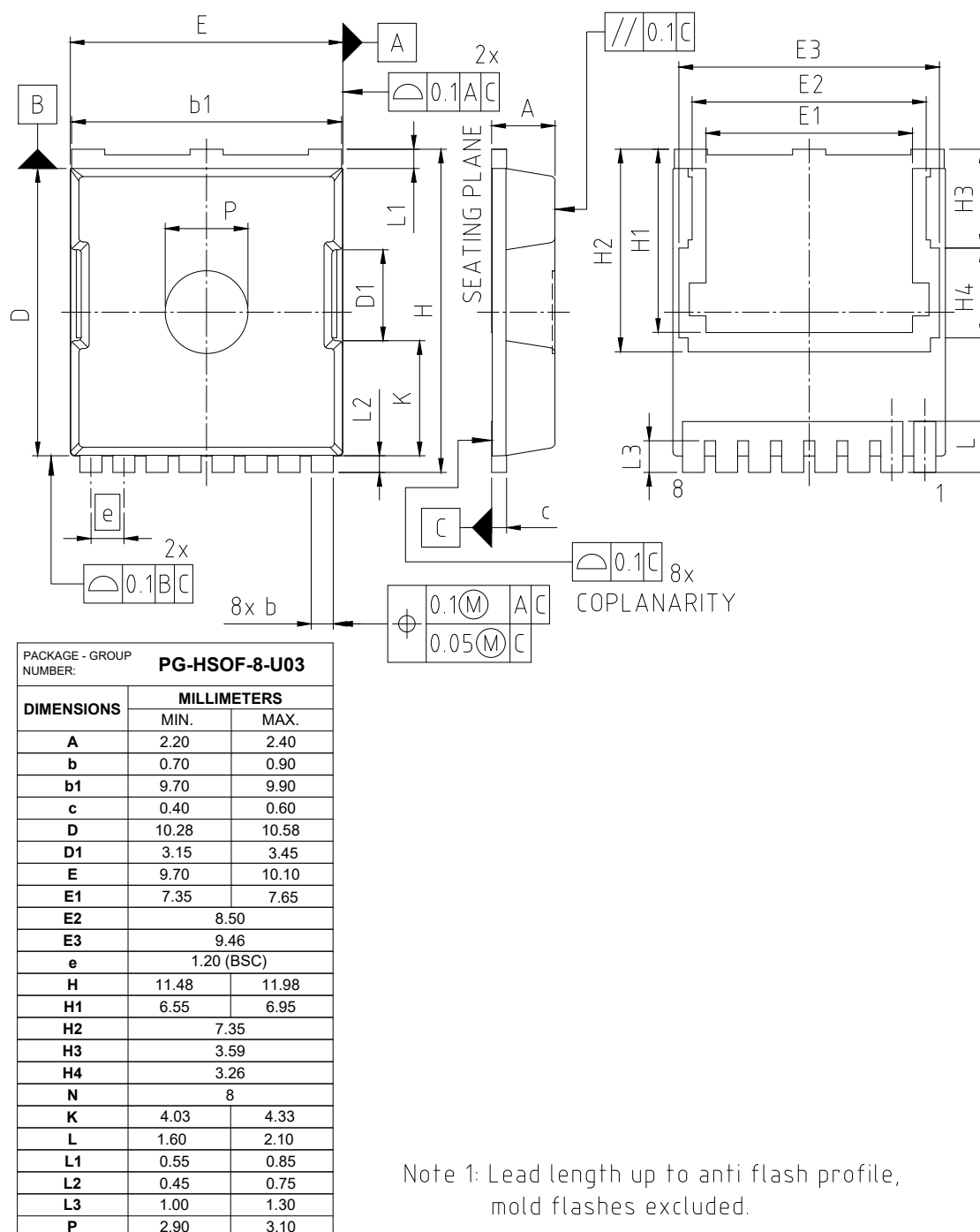


Figure 1 Outline PG-HSOF-8, dimensions in mm
