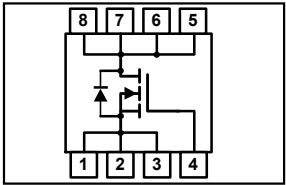

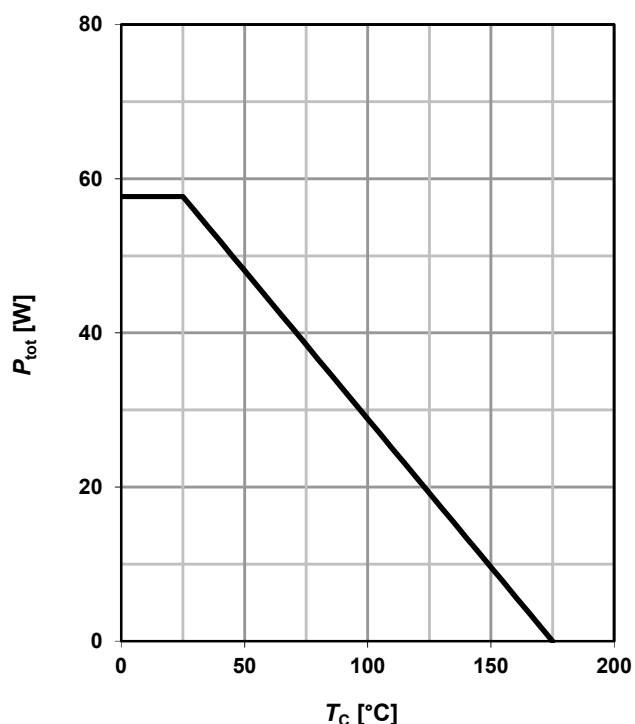

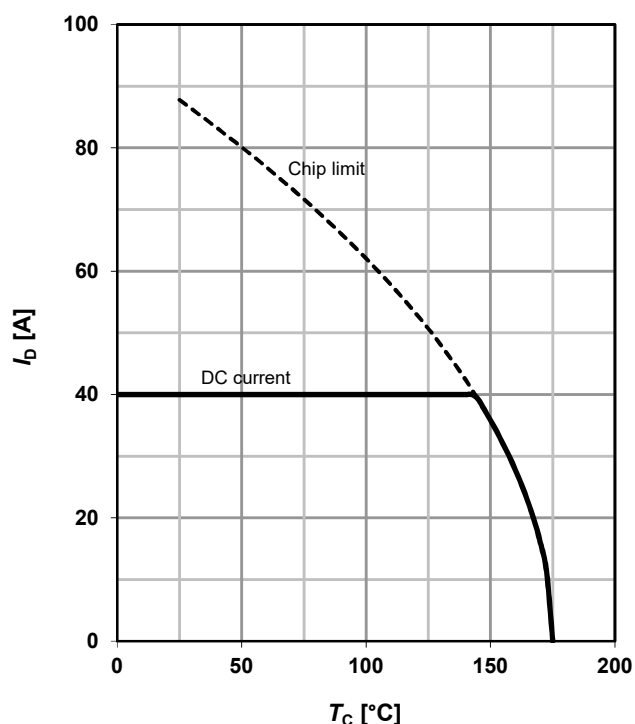
1 Power dissipation

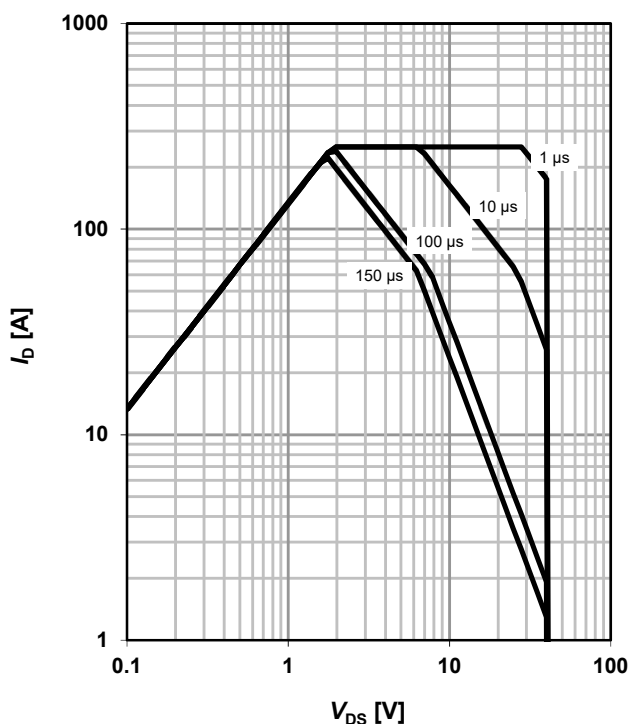
2 Drain current

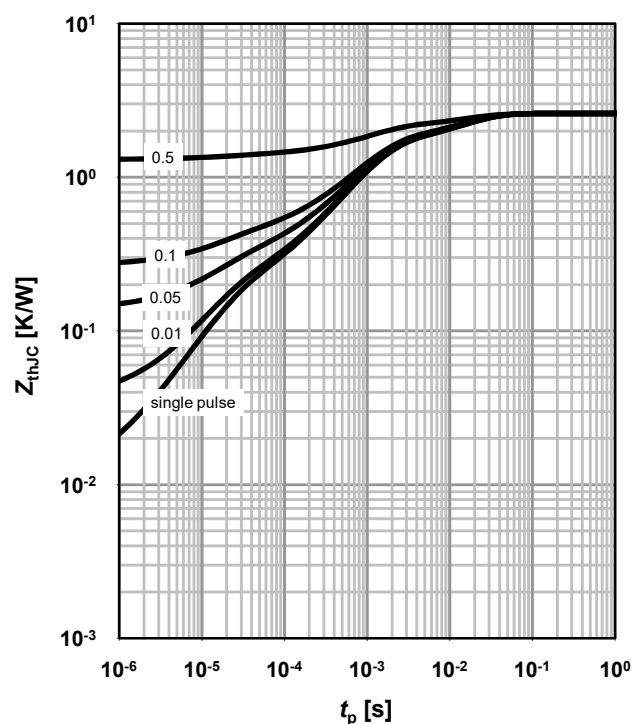
3 Safe operating area

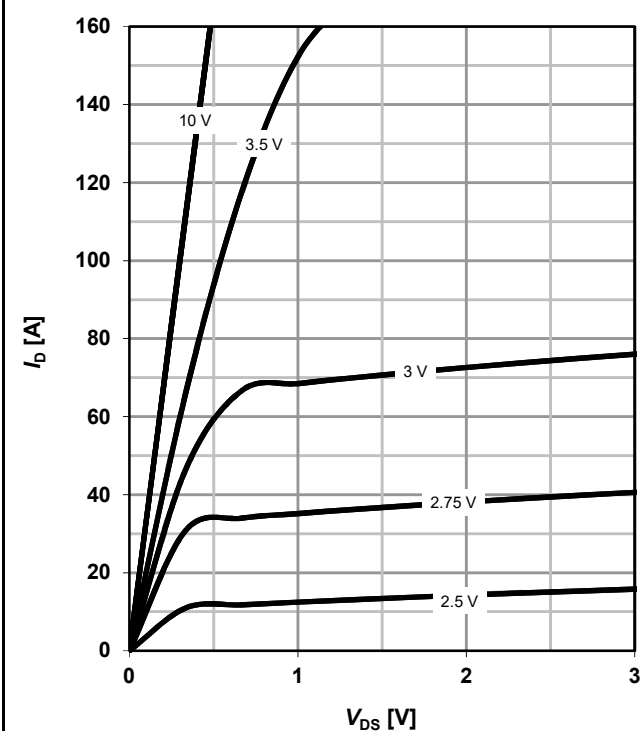
4 Max. transient thermal impedance

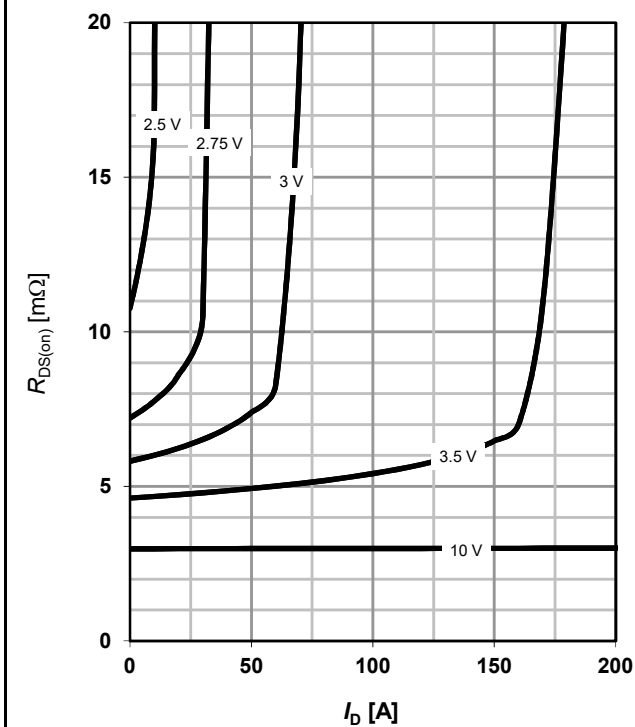

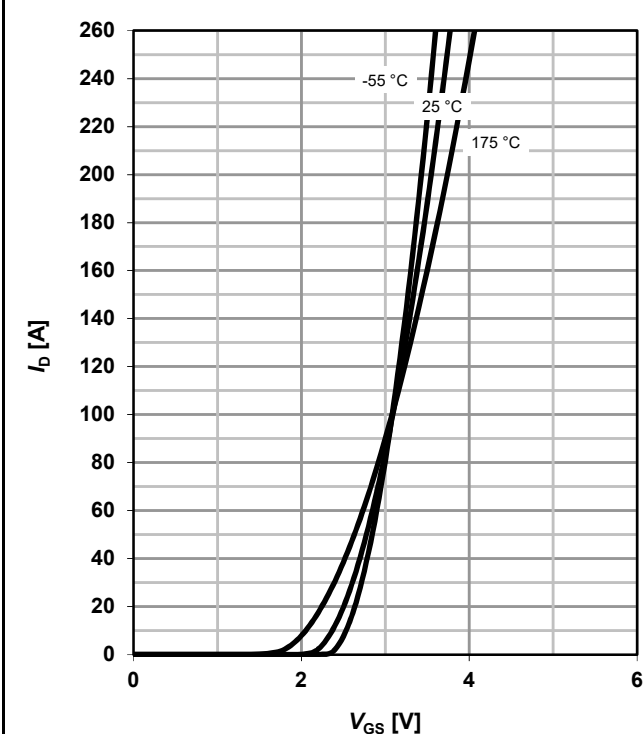

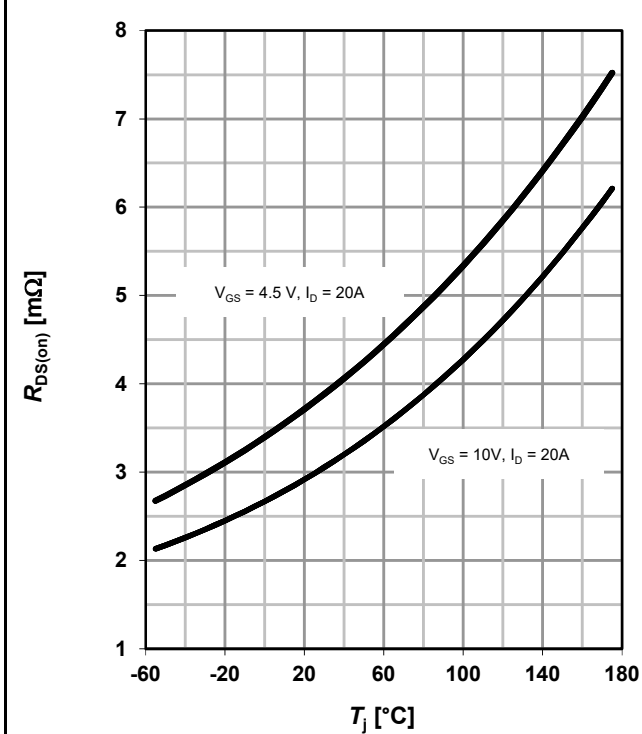

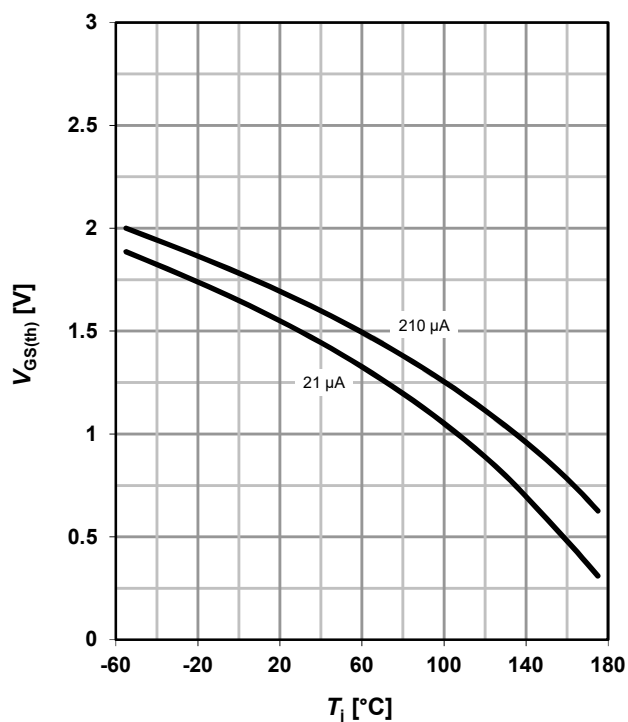

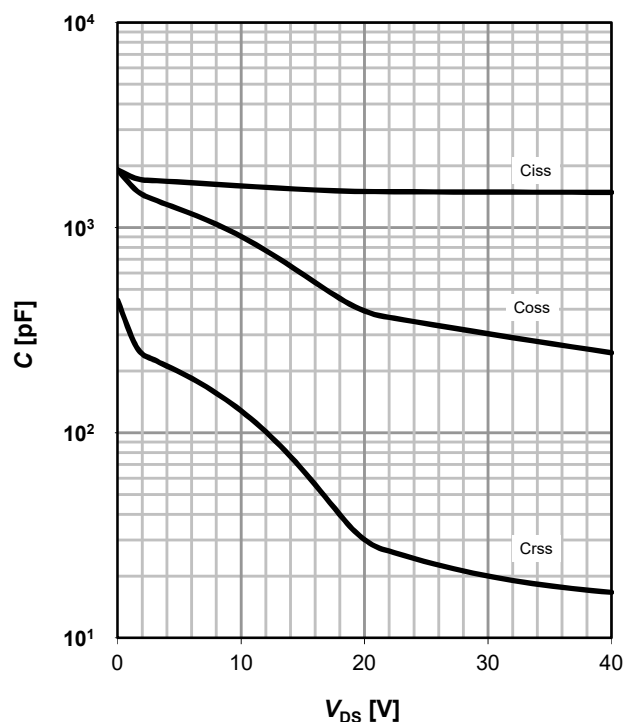

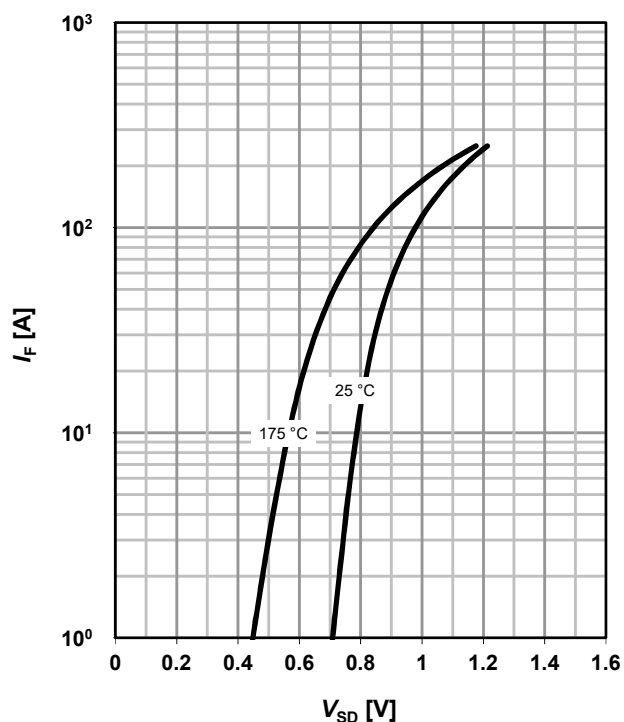

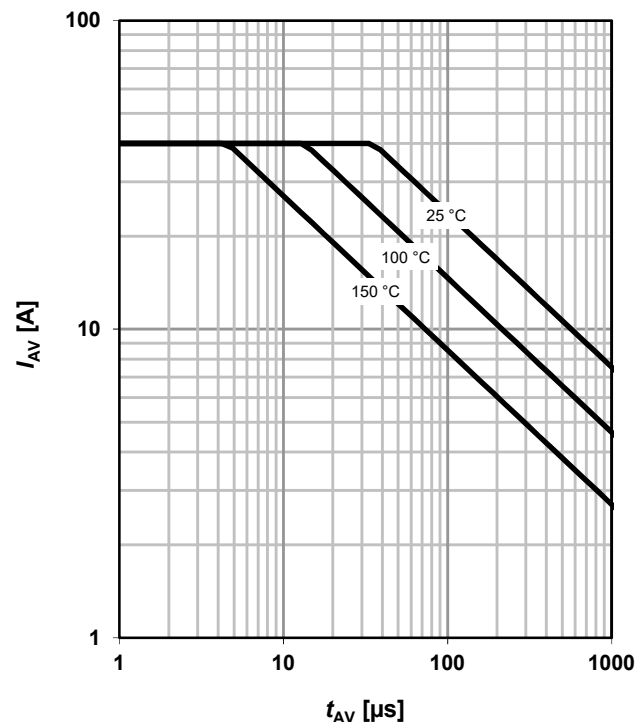
11 Typical forward diode characteristics

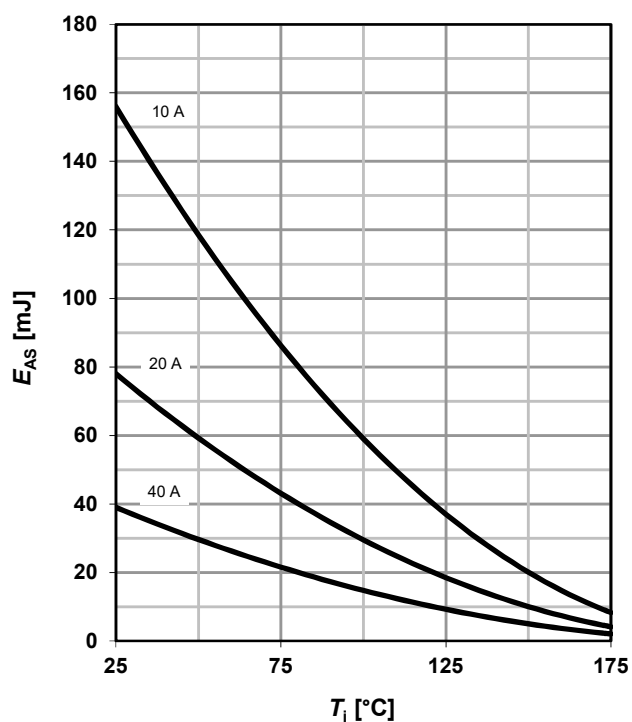

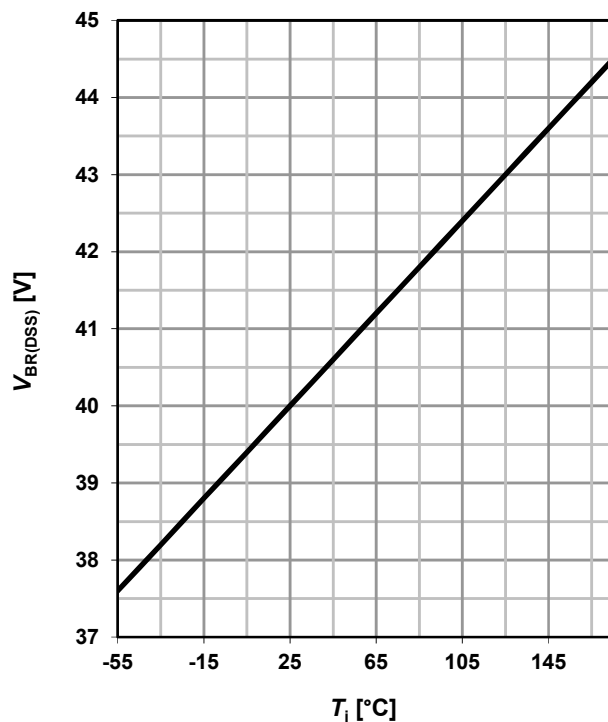
13 Typical avalanche energy

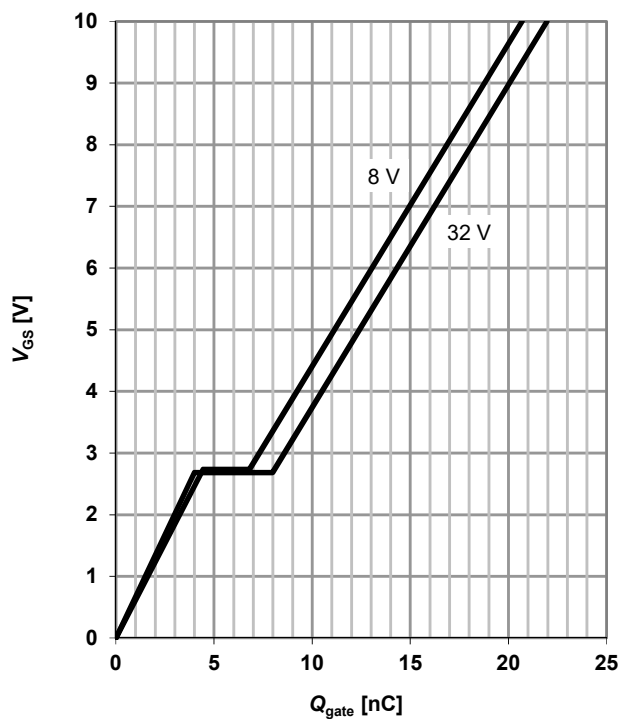

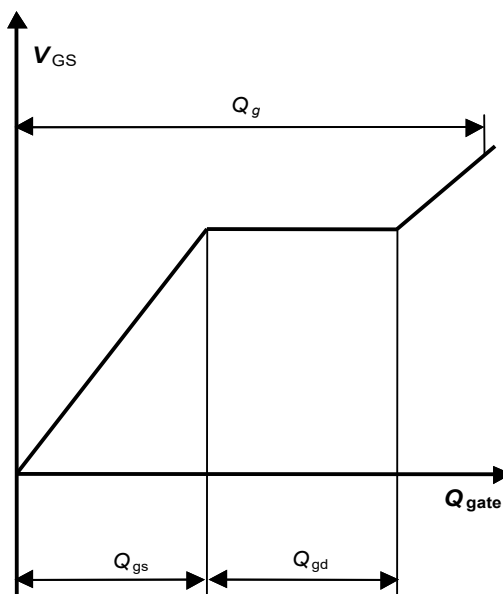

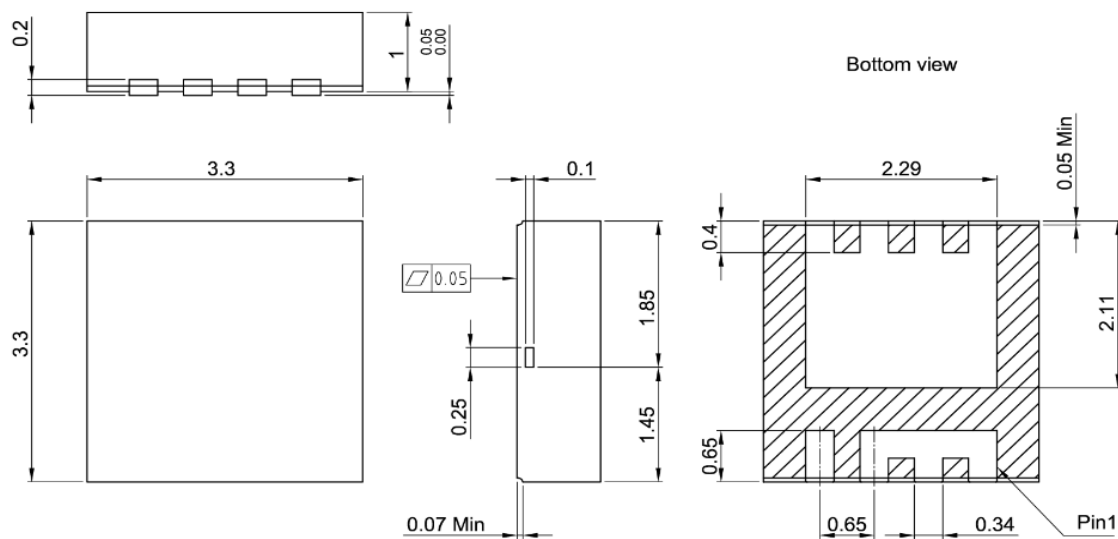

16 Gate charge waveforms

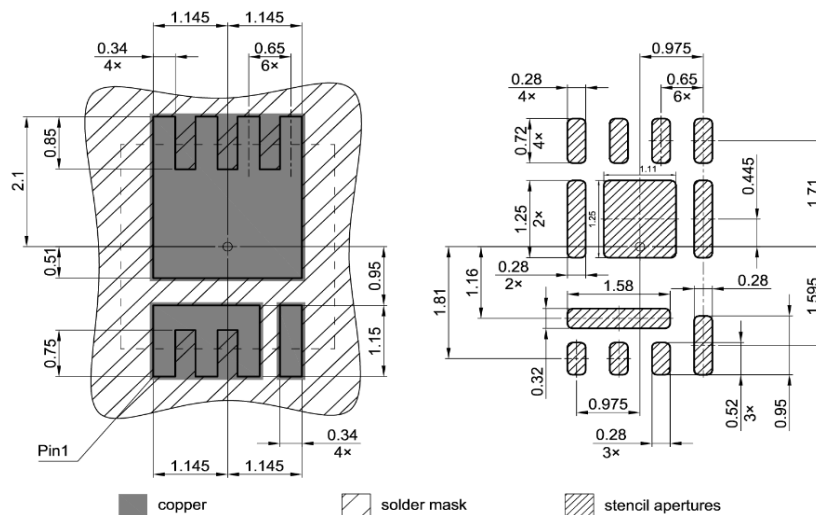

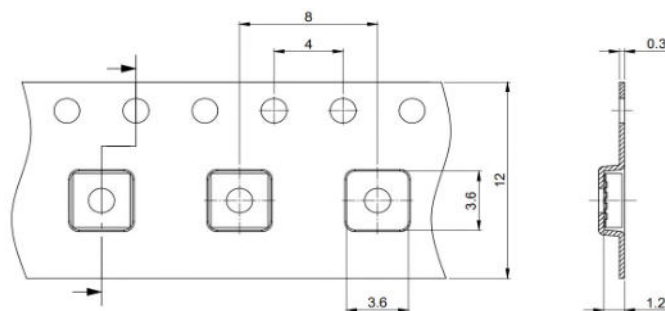
